An ordinance regulating and restricting the parking of motor vehicles on designated county owned property and parking lots.

It is hereby designated that County owned off-street parking shall mean the Jasper County Courthouse grounds, the Jasper County Parking Lot located at south third avenue west and second street south in Newton. Iowa, and the grounds owned by Jasper County surrounding the Jasper County Annex Building in Newton, Iowa. NO PARKING ZONES: No person or individual shall stop, stand, park, abandon, or leave unattended any motor vehicle on the county owned property adjacent to and surrounding the Jasper County Courthouse. Unless directed to by the Jasper County Board of supervisors, their designee, or a law enforcement officer. LIMITED PARKING AREAS: No person or individual unless as exempted herein shall stop, stand, park, abandon, or leave unattended any motor vehicle on the county owned property adjacent to or surrounding the county annex building, or the Jasper County parking lot as described above. Unless directed to by the Jasper County Board of supervisors, their designee, or a law enforcement officer. EXEMPTED INDIVIDUALS: Only those individuals that are assigned a designated parking spot by the Jasper County Board of Supervisor or their designee shall be allowed to park in the Jasper County parking lot or in the designated parking area adjacent to the Jasper County Annex Building. LIMITATIONS ON PARKING: No person or individual shall during the hours of 12:00 a.m. and 6:00 a.m., stop, stand, park, abandon, or leave unattended any motor vehicle on the county owned property adjacent to and surrounding the Jasper County Courthouse, on the county owned property adjacent to or surrounding the county annex building, or on the Jasper County parking lot as described above VIOLATIONS: Any motor vehicle found to be improperly parked standing, unattended, or abandoned, in violation of this ordinance may be removed and impounded at the direction of the Jasper County Sheriff or Jasper County Deputy Sheriff. Notice of said removal shall be mailed to the registered owner of the vehicle at the owners address as on the registration. Said notice shall specify from where the automobile was removed, where the automobile was placed after removal, the name of the individual or entity that removed the vehicle, that the owner may retrieve the automobile by payment of any towing fees, storage fees, or other fees associated with removal, impoundment, and storage of the vehicle. PENALTY: Anyone violating any of the provisions of this ordinance shall be guilty of a misdemeanor and upon conviction be punished accordingly. SAVING CLAUSE: If any section, sentence, clause, phrase or requirement of this ordinance is for any reason held to be invalid, such decision shall not affect the validity of the remaining portion thereof. The Jasper County Board of Supervisors hereby declares that it would have passed this ordinance and each section, sentence, phrase and requirement thereof, irrespective of the fact that any one or more sections, sentences, clauses, phrases or requirements thereof be declared unconstitutional. EFFECTIVE DATE. This ordinance shall be in effect after its final passage, approval and publication or posting as provided by law.



PENALTY: Anyone violating any of the provisions of this ordinance shall be guilty of a misdemeanor and upon conviction be pun-
