ORDINANCE
TO ESTABLISH

STREET AND AVENUE DESIGNATIONS

The purpose of this Amendment No. 3 to Ordinance No. IV-3 is to establish the name of a new portion of road in section 29-80-19 of Newton Twp., Lot B of Deer Run Subdivision. This road was accepted into the Jasper County road system on December 9, 1997 and therefore needs to be added to the 911 addressing system. The purpose of this amendment remains the same as stated in the original ordinance and this action is in compliance with Section 331.302 of the Code of Iowa.

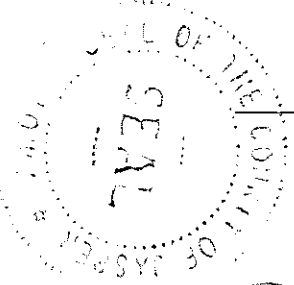
