**ORDINANCE TO ESTABLISH
RURAL ROAD
STREET AND AVENUE DESIGNATIONS**

The purpose of this Amendment No. 7 to Ordinance No. IV-3 is to add to the 911 addressing system those roads in Subdivisions the County accepted and roads added into the Secondary Road System. The purpose of this amendment remains the same as stated in the original ordinance and this action is in compliance with Section 331.302 of the Code of Iowa.

SECTION NO. 2: DETAILED LISTING AND DESCRIPTION OF ROAD SEGMENTS

Amend this section, as follows:

ADD as follows:

T-81N, R-20W (Independence Twp.):

828. Derby Avenue West of Baxter and north of F17 and described as: Lots "A", "B", and "C" in SSL Lakeview Estates Subdivision in the Southeast Quarter of the Southwest Quarter of Section 15, Township 81 North, Range 20 West of the 5th P.M., as appears in plat recorded in Book A at page 617 in the Office of the Jasper County Recorder.

T-79N, R-19W (Palo Alto Twp.):

829. S 29th Avenue E West of County Road S74 in Ennis Estates in Section 10-79N-19W of Palo Alto Township and described in Plat Cabinet A on Page in the Jasper County Records Office.

T-79N, R-17W (Richland Twp.):

830. E 142nd Street S The roadway south of S 12th Avenue East and approximately ¼ mile west of County Road T38 in Lakeview Ridge Estates in Section 2-79N-17W in Richland Township and described in Plat Cabinet A, pages 456 and 449 in the Jasper County Records Office.

T-79N, R-17W (Richland Twp.):

831. E 48th Street S Located approximately 1830 feet East of S 24th Avenue E on the north side of Liberty Avenue.

832. Law Center Drive Located approximately 2037 feet East of S 24th Avenue E on the north side of Liberty Avenue.

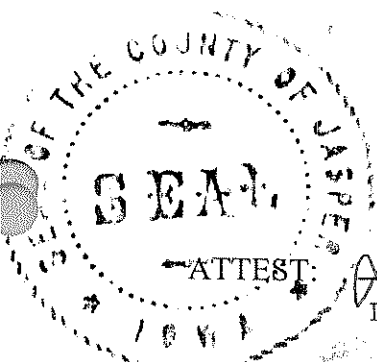
