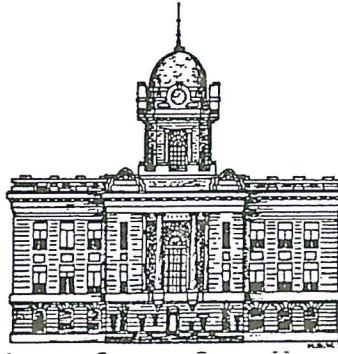

Tuesday, December 22, 2015 the Jasper County Board of Supervisors met in regular session at 9:30 a.m. with Supervisors Carpenter, Brock & Stevenson present and accounted for; Chairman Carpenter presiding.

Sheriff, John Halferty asked the Supervisors to approve a Memorandum of Understanding with the Iowa Department of Corrections that lays out an efficient and mutually beneficial arrangement for the holding of offenders who are alleged to have violated the conditions of their parole.

Motion by Brock, seconded by Stevenson to approve the Memorandum of Understanding between the Iowa Department of Corrections and Jasper County, for the holding of offenders that have violated their parole.

Engineer Russ Stutt and Assistant Engineer Pam Olson asked the Supervisors to approve a Federal Aid Agreement for the T12 Bridge, the purchase of a new pickup and the 2015 Weed Commissioner's Report.

Motion by Stevenson, seconded by Brock to approve a Federal Aid Agreement between Jasper County and the Iowa Department of Transportation for the Highway T-12 Bridge Project, BROS-C050(112)-5F-50. The cost of the project is estimated at \$750,000.
