

Tuesday, September 13, 2016 the Jasper County Board of Supervisors met in regular session at 9:30 a.m. with Supervisors Carpenter, Brock & Stevenson present and accounted for; Chairman Stevenson presiding.

Building and Grounds Director Adam Sparks made a request to the Board to purchase an automatic transfer switch to the generator located at the Armory. Quotes for a new 400a automatic transfer switch plus installation are as follow:

Motion by Brock, seconded by Carpenter to approve the purchase and installation of a 400a automatic transfer switch for the Jasper County Armory generator from Van Maanen Electric, Inc. for the amount of \$5,495.50.

Conservation Director Keri VanZante asked the Supervisors to approve the purchase agreement between Jasper County and Iowa Natural Heritage Foundation for Rail Bed Corridor between Prairie City and Mitchellville to be used for a bicycle trail.

Motion by Brock, seconded by Carpenter to approve a purchase agreement in the amount of \$882,548.96 between Jasper County and Iowa Natural Heritage Foundation for Rail Bed Corridor between Prairie City and Mitchellville to be used for a bicycle trail. The rail bed runs through Sections 18, 19, 20, 21, 27, 28, 34 and 35 Township 79 North, Range 21 and Fraction Sections 1, 2, 3 Township 78 North, Range 21 and Sections 5 & 6 Township 78 North, Range 20 and Section 13, Township 79 North, Range 22 in Jasper County.
