#### Jasper County Board of Supervisors:

This year will mark the 40<sup>th</sup> anniversary of Prairie City Officer Hewitt who died in the line of duty on December 3, 1977, he was involved in a motor vehicle pursuit when his vehicle was struck broad side and wrecked. I had a friend of the family approach me and asked about the possibility of having the bridge of Hwy 163 in Prairie City dedicated to Officer Hewitt and his sacrifice. It is my understanding that Officer Hewitt's accident occurred on Hwy 163, but I am working to verify this with the family. With the location of his death and this being the 40<sup>th</sup> anniversary I believe this dedication could have great meaning to the family.

This month I have been working with the DOT and Iowa State Patrol to find out what steps are required for dedicating a Bridge to a fallen Officer. The State Code in Iowa gives instructions for this process and indicates the local City Government must pass a resolution in support of the dedication as well as the County Board of Supervisors.

The bridge designation is BRIDGE ID 5000.1S117 (FEDERAL HWY NO. 601985). The dedication would change the name of the bridge to the Donald (Rusty) Hewitt Bridge.

During the October 4, 2017 regular Prairie City Council Meeting, the Council approved by resolution dedicating this bridge as described above. I have included with this memo a copy of the resolution.

I would request the Jasper County Board of Supervisors consider this request and if it is a project you can support I would ask that you pass by resolution your support. If passed I would then send the documentation to the State for final approval. I would take care of any costs associated with the sign and mounting, which are estimated to be around \$500.00.
