Hello.

We spoke earlier today regarding a request to gather at the Jasper County Courthouse on Wednesday, February 28. The gathering will be a peaceful rally in support of Deferred Action for Childhood Arrivals (DACA) calling on our elected leaders to pass a clean Dream Act. Our group will process to the Courthouse from Congregational United Church of Christ (308 E Second St N, Newton) and would like to gather on the southside of the Courthouse for a brief rally.
