

Tuesday, March 20, 2018 the Jasper County Board of Supervisors met in regular session at 9:30 a.m. Supervisors Brock, Carpenter and Cupples present and accounted for; Chairman Cupples presiding.

Newton Police Chief Rob Burdess asked the Supervisors to support the naming of Memorial Bridges for three Newton Fallen Officers. Officer Bobby Barrickman was killed in an on duty motor vehicle accident September 30, 1979. Officer Daniel McPherrren was killed in a shootout on September 13, 1985. Lieutenant Patrick Richardson died of a heart attack while training for the department's bi-annual fitness test on September 1, 2013.

Motion by Brock and seconded by Carpenter to adopt Resolution 18 – 22 supporting the naming of the following bridges which lie within or bordering the Newton City limits:

Officer Bobby Barrickman Memorial Bridge (Bridge#5068.3R080)

Officer Daniel McPherrren Memorial Bridge (Bridge#5063.9R080)

Lieutenant Patrick Richardson Memorial Bridge (Bridge#5066.3O080)
