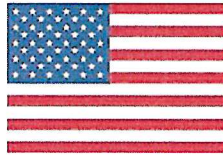

**MEMORANDUM OF UNDERSTANDING  
JAIL DETENTION BETWEEN  
JASPER COUNTY SHERIFF AND  
WARREN COUNTY SHERIFF**

**PARTIES**

This Memorandum of Understanding (hereinafter MOU) is made and entered into by and between the Sheriff of Jasper County, Iowa (hereinafter Jasper County) and the Sheriff of Warren County, Iowa (hereinafter Warren County).

**PURPOSE**

Warren County is in the process of constructing a new jail facility and needs a jail to house Warren County inmates during the period of planning and construction. The purpose of this MOU is to establish the terms and conditions under which the Jasper County Sheriff will confine inmates from Warren County.

Pursuant to the purposes set forth above it is agreed as follows:

1. **Terms and Conditions: Jasper County.** The Jasper County Sheriff agrees to confine and detain persons legally held in custody by Warren County, on the following terms and conditions:
  - a. The inmate must be legally in custody in Warren County, Iowa.
  - b. Jasper County will perform the duties and responsibilities of Sheriff or keeper of the jail as required by Chapter 356 of the Iowa Code and any state or local administrative rules and regulations applicable to inmates held by Jasper County.
  - c. All inmates will be subject to the jail policies and procedures approved by the State of Iowa and by Jasper County Iowa and utilized for the housing of inmates.
  - d. Payment by Warren County as set forth below:
    - i. Warren County will provide transportation for inmates that need short-term health care, need to attend mental health appointments, need to appear for Court proceedings outside of Jasper County and/or have been sentenced or otherwise ordered for placement for another facility (whether County or DOC).
  - e. An inmate may be granted work release privileges subject to the terms of the Jasper County Jail and by Court order.
2. **Terms and Conditions: Warren County.** The Warren County Sheriff agrees that in consideration for Jasper County's agreement to confine and detain persons for Warren County, Warren County will:
  - a. Pay the sum of **\$55.00** per day for each full or partial calendar day that an inmate is held in custody in Jasper County.

- b. Pay all medical, dental, substance abuse and mental health related expenses and prescriptions incurred by a Warren County Inmate during the period of incarceration. Jasper County will notify Warren County promptly in the event such expenditures are necessary. In a nonemergency situation, Jasper County will attempt to notify Warren County prior to incurring any such expense. Any such expenses shall be billed by the provider directly to Warren County when possible.
  - c. Provide all transportation both to and from the Jasper County Jail for any inmate incarcerated pursuant to the terms of this MOU.
  - d. Provide transportation to Court proceedings and if necessary to Department of Corrections Facilities following sentencing.
  - e. Reimburse Jasper County for any transportation costs incurred by Jasper County under 2(c) or 2(d) above. Reimbursement shall include hourly rates for a deputy and/or reserve officer providing transportation.
  - f. For each inmate, provide a copy of the warrant, complaint and affidavit, sentencing order and other necessary documentation for intake of the inmate into the Jasper County Jail. All inmates must report to the Warren County Sheriff for delivery and processing at the Jasper County Jail and will be released to the Warren County Sheriff for release from custody.
3. **Rejection of Inmate.** The Jasper County Sheriff may reject any inmate proposed by Warren County with cause, both before and after delivery of the inmate to the Jasper County Jail.
4. **Monthly Billing.** Jasper County will submit a bill to Warren County on a monthly basis. The billing statement will be itemized by inmate to include per diem fees and other expenses (i.e. medical, dental, etc. that have not been billed directly to Warren County). Warren County will pay the obligation in full within 30 days of the billing date.
5. **Inmate Holding Capacity.** If the Jasper County's facility inmate holding capacity is reached, housing Jasper County inmates will take priority over housing Warren County inmates. In the event Jasper County's holding capacity is exceeded, Jasper County will call Warren County and prepare inmates for transfer. Warren County will transport the Warren County inmates to another facility.
6. **Collection of Court-ordered Jail Fees.** Warren County will be responsible for collection of any Court-ordered jail fee that is to be paid by its inmates. In the event a Warren County inmate pays the jail fee to Jasper County, the jail fee paid will be delivered to Warren County.
7. **Hold Harmless.** Warren County hereby agrees to indemnify, defend and hold harmless Jasper County, its officers, agents and employees, from and against: Any and all claims, demands liabilities, obligations, actions, suits, proceedings, losses, damages, costs, expenses, assessments, judgments, recoveries and deficiencies, including interest, penalties and reasonable attorney's fees, of every kind and description, contingent or

otherwise (the foregoing hereinafter collectively referred to as “damages”), occasioned by, arising out of or resulting from the conduct, acts or omissions of Warren County, its officers, agents or employees and/or arising out of the placement of a Warren County Inmate under the terms of this MOU, unless the claim arises out of the gross negligence and/or intentional misconduct of Jasper County, its officers, agents or employees. A claim alleging, illegal confinement, false imprisonment or other violation arising out of the arrest, prosecution or judicial proceedings giving rise to confinement in the Jasper County Jail will be deemed to be conduct of Warren County.

8. **Access to Records.** Each party shall allow access to all records, documents and papers necessary for financial auditing of the parties’ transactions. Appropriate records, documents and papers necessary to conduct a financial audit shall be maintained for a minimum of three years.
9. **Period of Agreement.** This MOU shall become effective on the \_\_\_\_ day of \_\_\_\_\_, 2018. The MOU shall remain in effect through the completion of the Warren County Jail Facility, or upon 60 days’ notice by either Warren County or Jasper County that the MOU will terminate.
10. **Construction.** Words and phrases herein, including acknowledgment hereof, shall be construed as in the singular or plural number, and as masculine, feminine, or neuter gender according to context.
11. **Additional Terms.** This instrument contains the entire agreement of the parties with respect to the subject matter hereof; any other oral or written agreements entered into with respect thereto are revoked and superseded by this MOU. No representations, warranties or inducements have been made by either of the parties except as expressly set forth herein. Any changes, or modifications, adjustments, or amendments to this MOU must be in writing and agreed to by both parties.
12. **Notice.** Any notices required under the terms and provisions of this MOU shall be delivered by ordinary mail addressed as follows:

13. **Governing Law.** All matters pertaining to this agreement (including its interpretation, application, validity, performance and breach) in whatever jurisdiction action may be brought, shall be governed by, construed and enforced in accordance with the laws of the State of Iowa. The parties herein waive trial by jury and agree to submit to the personal jurisdiction and venue of a court of subject matter jurisdiction located in Warren County, State of Iowa. In the event that litigation results from or arises out of this Agreement or the performance thereof, the parties agree to reimburse the prevailing party's reasonable attorney's fees, court costs, and all other expenses, whether or not taxable by the court as costs, in addition to any other relief to which the prevailing party may be entitled. In such

event, no action shall be entertained by said court or any court of competent jurisdiction if filed more than one year subsequent to the date the cause(s) of action actually accrued regardless of whether damages were otherwise as of said time calculable. Any claims made by third parties against a party to this Agreement shall be governed and construed in accordance with Iowa law.
