

Tuesday, March 29, 2022, the Jasper County Board of Supervisors met in regular session at 9:30 a.m. Supervisors Talsma, Carpenter, and Cupples present and accounted for; Chairman Talsma presiding.

The Board of Supervisors received the County Compensation Board's letter of recommendations for Elected Officials salaries.

Motion by Cupples and seconded by Carpenter to adopt Resolution 22-28 Elected Officials salaries for FY22/23 as follows:

Auditor Dennis Parrott commented that the Supervisors, other Elected Officials and Department Heads had done an excellent job with their budgets. The County's portion of property taxes will not go up. For another year, the County will not be raising property taxes even in the face of an inflation rate of 7.5%. Colfax City Manager Wade Wagoner asked if that was actual dollars and how the County could do that. Supervisor Talsma

explained that because 1) the County cut its capital projects fund significantly, by buying and remodeling the new administration building, instead of fixing the old annex building. 2) combining current debt with the administration remodeling debt and 3) funding changes in the mental health program.

Motion by Carpenter and seconded by Cupples to close the public hearing.

Auditor Dennis Parrott explained to the Supervisors that the County had approved all the precincts in the County in January. The City of Colfax had their original redistricting plan rejected by the Secretary of State because they had sent in a plan with only one precinct, when in fact the City of Colfax has three precincts. The rejection caused Colfax to re-do their plan. The County had to amend its current precinct ordinance to include the re-done Colfax Precinct Ordinance plan.

There were no public comments.
