- 1.) Environmental Health report: Kevin Luetters/Jamie Elam from Community Development present. (Attachment 1 page) Septic inspections have started. The numbers are a little slower than in previous years due to the rain, but they are picking up. Jamie completed the 3 commercial septic pumper inspections for Jasper County. Kevin has helped submit 26 applications for the Water Infrastructure Grant. He helped submitted 26 applications which is one of the most in the state and 10 have been approved so far. He is optimistic the other 16 will be approved also. With the wind, there have been more nuisance complaints of trash in farmers' fields and dogs running loose. They have been working with the Supervisors and the County Attorney to clean up the rural areas of the county.
  - 2.) WIC: March report for WIC: Sierra Stevens, MICA-not present (Attachment 4 pages)

Public Health is still having discussions with MICA on ways to collaborate services and better service families in Jasper County.

3.) I-smile: 2<sup>nd</sup> quarter FY22 report, Melissa Woodhouse-not present (Attachment 3 pages)

Marion County has been able to provide more dental screening in Jasper County schools with the ease of COVID restrictions. With the IDPH region change, MICA has applied for the Maternal and Child Health grant to serve Jasper County.

Kevin and Jamie will be working with the pumpers more this year to make sure they understand the changes for next year. The inspections will remain the same.

## Jasper County Health Department Agency Report:

- Administrative updates: (Becky Pryor):
  - Fiscal report, FY 22 LPHS, Immunization, COVID response and PHEP grants have been completed for our county. PHEP funds still available for our region.
  - COVID equity marketing funds and COVID technology funds still need to be utilized.
  - Public Health Emergency Preparedness drill is being planned with Lynn Royer to be held on June 2 for mass casualty tabletop drill with hospital, 6 LTC, clinics, EMS, EMA, law enforcement, Progress Industries, Capstone, Optimae, etc.
- Health Department Assistant's report (Melissa Gary):
  - Homecare reimbursement: March's total hours were 40.5 total cost of \$1215.00. April's total hours were 35.25 total cost of \$1057.50. Cornerstone caregiving is admitting 2 more clients, with them there will be a total of 9 clients.
  - Inventory management: In the last couple of months, we have been inventorying the COVID Tech grant purchases. All equipment has been entered into Salamander System, tagged, and assigned to the departments and conference rooms.
  - SafeKids: On April 30, we participated in the YMCA's annual Healthy Kids Day Event. We gave out spring safety information along with other giveaways to 200+ people. May 4<sup>th</sup> was SafeKids Ride Your Bike to School Day. We wrote a SafeKids grant and received Bell bike helmets for the event. We worked with Officer Julie Britton and the Newton Police Department to hand out bike helmets, water bottles, and bike safety information to 22 kids at Berg Middle School. June will be a busy month for SafeKids. We are working with the YMCA on a swim and sun safety event at the Maytag pool. We are also partnering with Officer Britton again, to hold a bike rodeo and a car seat checkup event. Sleep sacks for safe sleep will go to Pregnancy Center.
- Public Health updates: (Kristina Winfield)
  - COVID update: According to the CDC, Jasper County is still in its low transmission area. There were 40 cases reported in March, 41 reported in April, and 40 reported in May so far, with a lot of at-home tests being used as well. It is unknown how many at-home tests have been taken.
  - Continuing to allocate COVID vaccine to clinics and pharmacies. There has been an increase in the need for vaccines with eligibility for another booster.
  - Becky and Kristina attended the Iowa Public Health Association Conference May 3-5.
  - Some increase in communicable diseases and immunizations.

Care coordination is provided to families when a child has suspected decay, a high-risk screening. <u>Each child</u> must have parental consent to participate.



#### What is a Hazard Vulnerability Assessment?

A Hazard Vulnerability Assessment (HVA) is a systematic approach to identifying hazards of risks that are most likely to have an impact on your healthcare facility and the surrounding community. This can include the demand for the facility to provide services or its ability to provide those services. HVA tools will put each hazard in perspective using categories such as probability, human impact, property and business impact and mitigation strategies. HVA's are evolving documents. Healthcare facilities conduct and/or annually review their HVA. The process should involve community partners, at a minimum the County Emergency Management Agency (EMA).

#### Purpose of the HVA:

Drive the focus of your Emergency Preparedness Program, plan development and updating and training for your organization

#### Goals of the Healthcare Coalition (HCC) HVA:

- o assess and rank potential HCC threats or hazards,
- o identify any potential HCC or system wide vulnerabilities or gaps,
- promote implementation of hazard mitigation strategies and plans,
- o develop/update the HCC 5-year training and exercise plan,
- o promote information sharing across the HCC about best practices related to threat preparedness.

#### How to conduct the HVA:

- 1. Assemble a multidisciplinary team no silos minimum of EMA.
- 2. Choose a tool and list out different hazards.
- 3. As a team, discuss the impacts and current mitigation of each hazard.
- 4. Document in the chosen tool.
- 5. Review and rank hazards using the data from the tool.
- 6. Discuss how your agency plans to address the identified hazards.
