

Tuesday, June 11, 2024, the Jasper County Board of Supervisors met in regular session at 9:30 a.m. with Supervisors Talsma, Stevenson, and Cupples present and accounted for; Chairman Talsma presiding.

Adam Sparks, Maintenance Director, presented quotes to install mini split units in the dispatch area of the Law Center. There were three quotes presented:

Motion by Cupples, seconded by Stevenson to approve the quote from Reeves Heating and Cooling in the amount of \$14,168.00 to replace the Leibert Unit with mini split units in the dispatch area of the Law Center.
