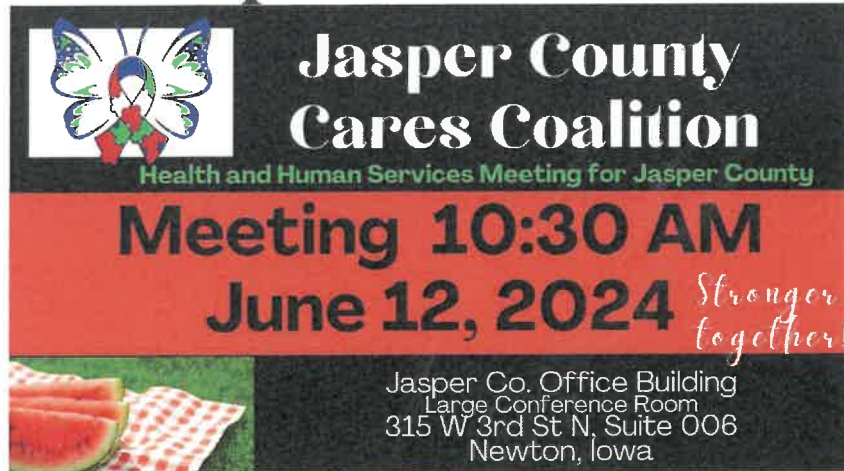



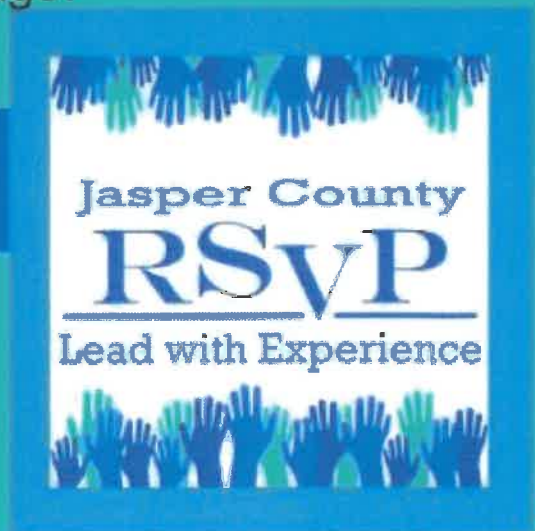

about habitat

Seeking to put God's love into action, Greater Des Moines Habitat for Humanity brings people together to build homes, communities, and hope.

Founded on the conviction that everyone should have a decent, safe, and affordable place to live, GDM Habitat seeks to transform neighborhoods and build brighter futures through affordable homeownership and owner-occupied repairs.



homeownership

Families apply for partnership through the GDM Habitat homeownership program based on three criteria: need for housing, ability to pay, and willingness to partner. Partner families complete sweat equity and Habitat homeownership program education. At closing, families purchase their home with an affordable mortgage.



housing counseling & financial education

Applicants who do not immediately qualify for our homeownership program are invited to participate in one-on-one counseling and group financial education classes. Our team of HUD-certified housing counselors helps each participant create a personalized roadmap to homeownership. Since 2017, nearly 1 in 3 Habitat homebuyers first completed housing counseling and financial education.



home preservation

GDM Habitat's Home Preservation Program brings homeowners, organizations, and volunteers together to assist low-income residents with owner-occupied repair, including maintenance, weatherization, safety, accessibility modifications, and beautification of homes.

why habitat?

Over the last 35 years, Habitat has been on the forefront of addressing affordable housing in Central Iowa. Since 1987, more than 450 families have had the opportunity to purchase a safe, affordable place to live, and 2,300 families have been helped to stay in their homes. Habitat continues to create, preserve, and champion homeownership affordability.

General

- **What are Alerts powered by Smart911?**
Alerts powered by Smart911 is the **Jasper County Emergency Notification System** official emergency alert and notification system. This system is used to send alerts to the public during emergencies. It is a free service that allows you to sign up online to receive customized alerts via text message, email, and voice message. You can also choose to receive customizable community notifications which include notifications about severe weather, safety, health, utility disruptions, etc.
- **How does it work?**
Alerts can be sent out city-wide to everyone who has opted-in to the system, or to a specific area or neighborhood for more localized events.

- **To update your existing preferences, click here.**

 - Login using your username and password.
 - Forgotten these, follow the instructions on the page under "Forgot Username/Password."
 - Once signed in, click the 'Preferences' tab at the top.
 - Under 'Notification Preferences', you can make changes to both the phone numbers and email addresses on which you want to receive messages by clicking or unclicking the checkboxes.
 - Choose what alerts you want to receive and the method (text, voice, email).
- **I don't own a computer – who can help me?**
You can go to your local library to use a computer or ask a relative/neighbor for assistance.

Hazard Vulnerability Assessment

What is a Hazard Vulnerability Assessment?

A Hazard Vulnerability Assessment (HVA) is a systematic approach to identifying hazards of risks that are most likely to impact your healthcare facility and the surrounding community.

Purpose of the HVA:

Drive the focus of your Emergency Preparedness Program, plan development and updating and training for your organization

Goals of the Healthcare Coalition (HCC) HVA:

- assess and rank potential HCC threats or hazards,
- identify any potential HCC or system-wide vulnerabilities or gaps,
- promote the implementation of hazard mitigation strategies and plans,
- develop/update the HCC 5-year training and exercise plan,
- promote information sharing across the HCC about best practices related to threat preparedness.

Jasper County top 10 hazard rankings based on your last HVA:

1. Inclement Weather
2. Communication Failure
3. IT Failure
4. Staffing Shortage and lack of training
5. Supply shortage/lack of storage
6. Human cause incidents/violence
7. Pandemic/Epidemic/Outbreak
8. Utility/Electrical Failure
9. Mass Casualty
10. Active Threat

The hazard-specific relative risk, by order of threat.

1. Human
2. Hazmat
3. Technological
4. Natural

Iowa Innovation in Homelessness Incubator

The Iowa Finance Authority (IFA) is proud to announce the first-ever Iowa Innovation in Homelessness Incubator - a challenge to Iowa housing and community leaders to think innovatively about how we can implement new approaches to alleviate homelessness in our state.

The Iowa Innovation in Homelessness Incubator calls for forward-thinking proposals aimed at addressing homelessness prevention and/or response. We seek innovative ideas that aspire to create a state where homelessness is rare, brief and nonrecurring and support is readily available to those in need. The goal is to redefine the landscape of homelessness prevention and response systems and rethink how assistance for persons experiencing homelessness in Iowa is delivered.

This initiative challenges Iowa housing and community leaders to think innovatively about how we can implement new approaches to alleviate homelessness. Whether it involves developing essential resources, introducing innovative tools, enhancing services, fostering essential partnerships, or streamlining processes, we're in search of solutions that transcend traditional funding mechanisms and programs.

The winning pitch will receive funding of up to \$100,000 to transform their concept into a pilot initiative, laying the groundwork for long-term impact, potential expansion, and measurable, life-saving outcomes. The source of funding for the award will be from state funds not subject to traditional federal program requirements, providing greater flexibility to innovate around homelessness prevention and response.

Guidelines

- Proposals must be led and submitted by a State of Iowa nonprofit service provider, certified Local Housing Trust Fund, City or County or by a statewide association. One or more nonprofit agencies that provides services related to homelessness prevention, rapid rehousing, and/or permanent supportive housing to persons experiencing homelessness in Iowa must be a key partner in the proposal if not the lead applicant.
- Proposals must be strategically aimed at alleviating homelessness with housing as the focus and have the potential to enact significant, broad-scale change (funding requests specific to financing the general operations of individual agencies are ineligible).
- Entrants are encouraged to consider person-centered responses to homelessness and include input from persons with lived experience.
- Proposals must have the potential to be replicated or expanded across the state.
- Proposal content and format is at the discretion of entrants and should be centered on innovation and supported by evidence-based practices.
- Partnerships are highly encouraged but not required.
- Proposals must be emailed to ifafyi@iowafinance.com and receive a confirmation email.
- Finalists will be determined by IFA and will be invited to make their pitch to a panel of expert judges at the [HousingIowa Conference](#) in Des Moines on Thurs., Sept. 5.
- Entrants are not guaranteed an opportunity to pitch or funding and must sign an [acknowledgement form](#) prior to submission of proposal.

- Sept. 5: Finalists make their pitches at the HousingIowa Conference
