5.3.3

The minimum distance of a storage container to dwellings or to population centers shall be in accordance with the requirements of the local AHJ.

5.3.4

In the absence of specifications of minimum distance by local jurisdictions, separation distance(s) for new, additional or relocated ammonia <u>stationary</u> storage containers and placements of containers covered by Sections 9, 10, 11, and 12 after January 1, 2002, shall be in accordance with Table 5.

5.3.5

Container storage areas shall be accessible to emergency vehicles and personnel.

5.3.6

Areas within 10 ft (3 m) of a storage container shall be maintained clear of dry grass and weeds and other combustible materials.
