2024 MEETING MINUTES OF THE JASPER COUNTY COMPENSATION BOARD HELD DECEMBER 17, 2024

The 2024 Meeting of the Jasper County Compensation Board was held on December 17, 2024 at 6:00 p.m. in the Courthouse Board of Supervisor's Room at the Jasper County Courthouse in Newton, Iowa. Present for the meeting were Allison M. Udelhoven, Denny Stevenson, Nancy Parrott, Jake Hedgecock, Bret Doerring, Denny Vander Weerdt, and Jason Morgan. Also present in the room were two County Supervisors and various members of the public and represented departments.

<u>Chairman</u>: Jason Morgan was nominated Chairman and Allison M. Udelhoven was nominated Secretary with unanimous approval of the Board.

<u>Call to Order:</u> The Chairman called the meeting to order at 6:01 p.m. and the members recapped the procedure from the prior year, including the recommended figures for each department from the prior year. Members discussed recommending a dollar amount increase instead of a percentage increase and discussed recent changes to law which include supplementing the minutes of the meeting with rationale or "showing your work" for recommended increases to pay.

Jasper County Sheriff: A motion was made by Jake Hedgecock to increase the annual salary of the Jasper County Sheriff to \$160,000.00 (increase of \$14,831.00). Nancy Parrot seconded the motion. Motion carried.

Jasper County Attorney: A motion was made by Allison M. Udelhoven to increase the annual salary of the Jasper County Attorney to \$160,000.00 (increase of \$14,745.00). Bret Doerring seconded the motion. Motion carried.

Jasper County Auditor/Treasurer/Recorder: A motion was made by Nancy Parrot to increase the annual salary of the Auditor, Treasurer and Recorder to \$100,000.00. Jake Hedgecock seconded the motion. Motion carried.

Nancy Parrot motioned to convert her recommendation to a dollar amount, clarifying that the motion for the Auditor/Treasurer/Recorder salary increase would be a recommendation for an increase of \$5,304.00 (equating to \$100,000.00). Jake Hedgecock seconded the motion to convert recommendation. Motion carried.

Jasper County Supervisors: A motion was made by Bret Doerring to increase Jasper County Supervisor salary by \$2,500.00. Nancy Parrot seconded the motion. Motion carried.

A motion was made by Bret Doerring to continue the \$2,500.00 stipend. Denny Vander Weerdt seconded the motion. Motion carried.

<u>Rationale</u>: The members discussed how to best report the rationale of the Jasper County Compensation Board for its recommendations to the Jasper County Supervisors. It was decided

through informal discussion that a separate document would be provided, and the idea was proposed that one or more members of the Jasper County Compensation Board may attend the meeting of the Jasper County Board of Supervisors to supplement such report.

Adjourned: There being no further business to come before the Jasper County Compensation Board, the meeting was, upon motion by Jake Hedgecock and seconded by Denny Vander Weerdt, duly adjourned at 7:01 p.m.

2024 RATIONALE REPORT OF THE JASPER COUNTY COMPENSATION BOARD RECOMMENDATIONS

Allison M. Udelhoven, Denny Stevenson, Nancy Parrott, Jake Hedgecock, Bret Doerring, Denny Vander Weerdt, and Jason Morgan; with contributions from the various departments and their staff

General Principles, Considerations and Rationale:

Retention and prioritizing remaining competitive with the metropolitan population is at the forefront. In light of our geographic proximity to metropolitan areas, we are at high risk of our elected officials leaving to be better compensated with less responsibility.

The board also seriously considers the nature of elected official jobs. Elected officials must contend with public perception and that same burden does not exist with appointed department heads or private sector jobs. We want to promote quality candidates and a necessary part of that is ensuring fair compensation for those unique expectations placed on elected officials.

Jasper County Sheriff: Recommended Increase of: \$14,831.00

The board considered the compensation of three police chiefs of communities greater in size and three police chiefs of communities smaller in size and averaged the amount to determine a range of compensation. A sheriff oversees an entire county, which carries with it greater responsibility than that of a police chief. The board considers the salaries of similarly situated police chiefs and similarly situated county sheriffs to reach its recommendation. The board's recommended salary increase would bring the Jasper County Sheriff into that averaged range of comparable salaries. See attached Sheriff Information document. Another note to add is that it was discussed at the meeting that, historically, Jasper County has aimed to keep the County Attorney and Jasper County Sheriff in a similar compensation range.

Jasper County Attorney: Recommended Increase of: \$14,745.00

To determine comparable salaries for the Jasper County Attorney, the board cannot merely rely on compensation of those county attorneys in areas with a similar population. The board must also consider compensation of county attorneys in other high traffic areas. Jasper County is located on a major interstate, which unavoidably results in more frequent, higher-level offenses. For this reason, the board considers from the Iowa State Association of Counties, the salaries of the County Attorneys in those counties similarly situated on a major interstate or roadway, including Pottawattamie County (\$167,168.00), Story County (\$177,522.00), Cerro Gordo County (\$151,966.00) and Warren County (\$157,723.00). Each of the aforementioned counties are within no more than 8 rank points for population of Jasper County. The compensation of these county attorneys, averaged, is \$163,594.75 which is comparable to what the board believes the Jasper County Attorney should be compensated. This is why we recommended a \$14,745.00 increase which would bring the Jasper County Attorney's compensation to \$160,000.00. All figures derived from ISAC Salary Survey Report FY2025.

Jasper County Auditor: Recommended Increase of \$5,304.00

Jasper County is seeing an increase in development projects throughout the County. Jasper County's location is very appealing with the I-80 corridor and having access to so many amenities the metro has to offer. The Auditor's Office has worked on implementing a model

plan for Developers to put in large subdivisions within the County that will increase tax revenue. The Auditor's Office also played a major role in the Newton Legacy Plaza Reinvestment District that was one of the only projects to pass through the Iowa Economic Development Authority and is a model for the State of Iowa. Developer, Jake Christensen, is in the process of remodeling the old Maytag facilities into 70-unit luxurious market-rate apartments, a 58-room boutique hotel, and green space area that will offer many opportunities.

The Auditor's Office works closely with the Board of Supervisors to continue to try and keep Jasper County property taxes low. Every year the Auditor's Office spends countless hours combing through its budget process to ensure Jasper County levy rates are not rising, creating an increase in taxes for Jasper County citizens. It is a very tedious job as inflation continues to grow. The Auditor's Office tries to offer the same services year after year at the same low costs.

Similar Counties that are growing are very comparable to the current wages are Marshall County (\$94,114.00), Story County (\$114,920.00), Dallas County (\$121,768.00), and Pottawattamie County (\$101,970.00).

Jasper County Treasurer: Recommended Increase of \$5,304.00

The Jasper County Treasurers office saw great growth in all three departments last year.

Tax/investments: The Treasurer's Office was able to leverage Jasper County's assets with the addition of Leighton Bank this year. That helped the Treasurer's Office beat its projections by over \$700,000.00 (over one million after accruals). The crew in the tax department streamlined the postage system both in tax notices and delinquent notices which saved a tremendous amount of postage dollars for the year.

Driver's License: Jasper County had another record year in Driver's License. Jasper County is the second busiest driver's license county operated station in the state, and according to its staff, issued well over 12,000 cards last year. Only Warren County does more DL's per year than Jasper County, according to staff. Jasper County also outperformed several state driver's license stations in major cities that have staff levels 20-30% higher than the Jasper County office.

Motor Vehicle: As of January 1st, Iowa residents can now title their vehicles in any county in Iowa. Jasper County has already seen an uptick in private transactions. According to the Treasurer's Office, Jasper County has also negotiated with two major dealers outside of Jasper County to process their dealer transactions here as well. The new fee increases passed by the Iowa legislature along with the dealer transfers are expected to produce an additional \$150,000-\$200,000.00 in revenue next year. The Jasper County Treasurer's Office is in discussions as to whether it will need to add an additional employee to handle the influx of new transactions.

Title fees will increase by \$10.00 each. According to the Treasurer's Office, they processed 14,433 titles last year. That alone is expected to increase revenues by over \$144,000.00.

According to the Treasurer's Office, two examples of counties that are the same size as Jasper County but do not offer Driver's License services are Cerro Gordo and Clinton. The Cerro Gordo Treasurer is paid \$93,642.00 and Clinton is paid \$93,606. This is while only covering two-thirds of the daily business the Jasper County Treasurer's Office covers and staffing the same or more employees without offering Driver's License issuance. All compensation figures derived from ISAC Salary Survey Report FY2025.

Jasper County Recorder: Recommended Increase of \$5,304.00

According to the Jasper County Recorder's Office, for FY 23/24, the office processed \$42,435.00 in certified copies of vital records and marriages. This is based on a rate set at \$15.00 for certified records and \$35.00 for marriage licenses.

For the DNR side of the office, boats, and off-road vehicles can be renewed statewide. The Recorder's office has many customers who travel to Jasper County to get DNR services due to the customer service and accessibility. According to the Jasper County Recorder's Office, Boat registration renewals began January 1, 2025 which is approximately 3000+ boats that come due at once. Boats can be renewed in any recorder's office by anyone with an Iowa boat registration. For FY23/24 the office collected \$54,391.00 in DNR transactions.

Being next to Polk County is a huge boost for the Jasper County Recorder's office as it brings in customers that are on the fringe of adjacent counties or live in counties with longer travel distances to the county seat. As of current, titling of OHVs and boats must be done in the resident county. The Recorder expects that in the future, titling will be available statewide for any recorder's office and will open the door for higher revenue collections in Jasper County.

According to the Jasper County Recorder, during the calendar year, 2024, the Jasper County Recorder's office recorded 6266 documents. (Numbers can vary due to the economy.) In addition, transfer tax, sales, and local option tax is collected for both county and state.

Total revenue collected for the State of Iowa and Jasper County combined for FY 23/24 by Jasper County Recorder staff was \$693,266.00 of which \$235,917.00 went to the Jasper County general fund. It is expected that revenue will increase with possible legislative changes by the Iowa Department of Natural Resources and Iowa County Recorder's Association.

Jasper County Supervisors: Recommended Increase of \$2,500.00 and continue \$2,500.00 stipend The board considered the fact that the Jasper County Supervisors declined to accept a salary increase at least eight of the last ten years. The Board of Supervisors did accept an increase following last year's meeting, so the consensus this year was that by recommending a \$2,500.00 increase in compensation the Board could determine what is necessary to reasonably accommodate the demands of the job. In considering reasonably similar counties, the board considers Cerro Gordo County (\$52,460.00), Des Moines County (\$42,701.00), and Marshall County (\$45,925.00). The compensation of the Supervisors in these counties, averaged, is \$47,028.66 which is comparable to what the board believes the Jasper Board of Supervisors should be compensated with adjustments to be made according to the Supervisors' judgment. All figures derived from ISAC Salary Survey Report FY2025.

Dear Members of the Jasper County Compensation Board,

As the Jasper County Attorney's Office reflects on the 2024-2025 year, I am proud to present the significant accomplishments and trends that define our work in service to the Jasper County. Our commitment to justice, the safety of our citizens, and active community engagement remains.

The accompanying pages include:

- 1. **Case Filing Statistics:** A table summarizing the total number of criminal, civil, and juvenile cases filed by our office from January 1, 2024, through December 10, 2024.
- 2. **Case Trends:** A graph illustrating the total number of criminal cases and felony cases filed annually from 2018 to the present. While the total number of criminal cases has remained consistent, the number of felony cases continues to rise, underscoring the increasing complexity of our work.

Additionally, there are specific trends and charges worth highlighting:

- Sex Offense Charges: Alarmingly, we filed 57 sex offense-related charges in 2024 (18 were filed in 2023-2024), marking a significant and troubling rise.
- Stalking Cases: This year, we filed 5 stalking cases—a notable increase compared to previous years.
- New Charges: In 2024 our office filed multiple high-level charges that either have not been filed in Jasper County before or due to new laws in Iowa. These included:
 - o Delivery of a Controlled Substance Causing Death
 - o Domestic Abuse Assault on a Pregnant Person
 - o Sexual Exploitation of a Minor (Internet/Cellular Solicitation)
 - o Witnesses Tampering
 - o Theft Against Older Individual
 - Eluding 2nd or Subsequent Offense

Our dedication to serving Jasper County extends beyond case filings. Members of our office are deeply involved in initiatives that strengthen our community:

• Open Arms of Jasper County: A nonprofit providing critical support and resources to children and families.

- Jasper County Drug Endangered Children Team (Jasper DEC): A multidisciplinary effort to ensure the safety of children in drug-related environments.
- Jasper County Sexual Abuse Response Team (SART): Promoting thorough investigation and effective support for sexual abuse victims.
- Iowa Professional Society on the Abuse of Children (Iowa PSAC): Educating and improving the response of professional related child abuse cases.

These efforts highlight our role as not only legal advocates but also proactive contributors to Jasper County's well-being.

In addition to these community efforts, it is important to highlight that all five attorneys in our office are on call 24/7 to assist law enforcement with urgent matters. This includes handling phone calls for search warrants, charging decisions, and other time-sensitive requests that can be needed at any time of day. This level of commitment demonstrates our office's dedication to ensuring the legal needs of law enforcement and the community are met at any hour. Likewise, attorneys in our office are on call to answer legal questions from Elected Officials and Department Heads in Jasper County on an as-needed basis..

The rising felony caseload and the concerning increase in certain types of offenses demand a dynamic and well-supported legal team. We are committed to continuing our essential work and are grateful for your consideration of the resources needed to achieve these goals.





Dear Supervisors,

Replacement of Bridge D05 is programmed for FY2025, the current fiscal year. Bridge D05 is located on N 107th Ave W 1.2 miles east of W 100th St N in Independence Township and crosses Clear Creek. The current bridge is combination of a riveted pony truss and steel I-Beam bridges. Original riveted pony truss bridge was constructed in 1914 and modified in 1940. Estimated remaining life in 2023 was 1 year. Bridge will be replaced with a 120 foot single span steel beam bridge with a reinforced poured concrete deck and will be set over steel backwall abutments (substructure). Day labor will be used to construct the new bridge while materials will be let locally and placed under contract to keep the county under the state required horizontal infrastructure limit (bid threshold) of \$115,000.

Given the need and available funds, a request for bid proposal was sent out to Oden Enterprises, Husker Steel, and Nucor on July 23, 2024, for the superstructure package (steel bridge beams, deck reinforcement, etc.), only Oden submitted a bid, so after board approval of award a contract was issued to Oden Enterprises on August 20, 2024 for \$377,388.70. Contract also included final design work to ensure that the bridge could be properly rated. Delivery of the superstructure package is anticipated in April 2025.

Following up the superstructure package bid we prepared a second request for bid proposal regarding the substructure packages (abutments). This process took a few months as existing conceptual design information was not current and needed to be updated before it could be included with the request for bids. On December 30, 2024, the substructure package request for bid proposal was sent out to Oden Enterprises, Husker Steel, and Nucor. Substructure package bid also included final design work as required to ensure the bridge could be properly rated.

Only one bid was received. Oden Enterprises submitted a bid for \$87,050.72. Engineers estimate for this work was \$130,776. Estimate was based upon market value information and assumptions regarding final design costs. A review of past bid information showed that the substructure for Bridge S23 replaced in 2023 was \$92,733.16, so steel prices appear to be steady or trending down.

Total cost for Bridge D05 steel (superstructure and substructure) from Oden Enterprises is now \$464,439.42. FY2025 program allocated \$400,000 for contract work and \$120,000 for day labor work. I anticipate the amount spent on day labor will be less, resulting in a final spend for Bridge D05 at or less than 10% above the \$520,000 budgeted for the project.

After consideration of the bid submitted by Oden Enterprise and the reasonable prices received, the Jasper County Highway Department recommends approving the proposal from Oden Enterprises for substructure packages for Bridge D05 at a total cost of \$87,050.72






